- 5. Bids shall opened in the presence of Bidders' representatives who choose to attend at 12:30 pm on 2079/01/11 BS (24th April, 2022) at the office of Fisheries Development Center, Geta, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 82,000/- (Eighty Two Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.
